# Standards Committee Review Requirements

Addendum 4 of building SMART International Process

The bSI Process explains that the Standards Committee (SC) is primarily concerned on whether the bSI Process has been followed. The SC does not vote on the technical merits of a new solution or standard. (The technical assurance is addressed within the project.)

The SC makes different assessments depending on whether they are being asked to endorse a *Standard* or a *Technical Report*.

# Process for endorsing a Standard

The Standard / Solution creation activity is sent to the SC four times during the creation lifecycle and at each phase slightly different questions are asked.

Below are listed the questions that have to be asked of the SC for each phase.

## Activity proposal

- b. Member Organization or Chapter)

a. Is the proposal relevant for being developed in to an international standard, supporting digital workflow for the built asset industry?


